The float of the buoy is warranted for three years from the date of sale: that it will maintain its flotation when used for its intended purpose under exposure to normal sun, wind, weather, and water conditions. It is NOT warranted against acts of vandalism. It is NOT warranted against attack by animals, birds, fish, or people. The hardware of the buoy is warranted for one year from the date of sale: that it will maintain its structural integrity when used for its intended purpose, under normal exposure to weather and water conditions.
